About the Magadh University, Bodh Gaya

Magadh University is located in cultural city of Bihar, Bodh Gaya. It is in the vicinity of Mahabodhi Temple which is a UNESCO world heritage site. It is one of the largest universities in Bihar. At present, there are 19 constituent colleges, about 100 affiliated Degree Colleges that includes Law colleges, Engineering Colleges, B.Ed. Colleges and Pharma colleges of the University spread in five districts (Gaya, Nawada, Jehanabad, Arwal and Aurangabad). There are 37 departments in university offering traditional and vocational courses. The University is a brainchild of the eminent educationist and then Education Minister of undivided Bihar, Shri Satyendra Narayan Singh (later Bihar CM). The conference aims to critically examine the dynamics of electoral politics, party systems, and democratic institutions, focusing on challenges such as authoritarian drift, populism, and institutional decay.

Conceptual Framework

In a nation-state as vast and diverse as India—with its multilingual, multiethnic, and multicultural identity—democracy serves not just as a form of government but as a lived experience for over a billion citizens. The role of political party and Election Commission (EC) are key in ever evolving multifaceted democracy in India.

Elections in India have become phenomena happening all round the year, whether parliamentary, presidential, state legislatures or by-polls. This keeps the EC engaged for most of the times. The expansion in politicisation of Indian society has raised the number of contestants and voters. In this ever-increasing competitive political arena, safeguarding democracy and maintaining rule of law is serious responsibility which establishes or breaks trust in the EC. The EC's autonomy in the face of governmental controls has also come under the scanner. The jurisdiction of EC encompasses drawing out voters, conducting a safe election, handling election violence, reducing ruling party/parties' excesses, and curbing money and muscle power.

Parties across the political spectrum have tended to converge on macroeconomic policy, but continue to diverge on social policies and larger issues that confront India, such as nation building and secularism. Chronic lack of internal democracy coupled with the rise of political corruption and clientelist practices are matters of serious concern.

In recent decades, there has been an impressive mobilization of the poor and marginalized groups, including the lower castes and women, which has been reflected in voting, in participation in local government, and in the leadership that has come to power. If India continues to grow economically at a rapid pace, a reinvigorated and stronger democracy will soon be put in place.

Elections in India are the largest exercise of democratic participation in the world, and political parties—ranging from national parties to regional parties—play a pivotal role in shaping the discourse, direction, and destiny of the democracy. But as our electoral landscape evolves in response to social transformations, digital disruptions, and citizen activism, key questions emerge: Are political parties truly representative? How do elections empower or fragment the democratic spirit? What reforms can deepen democratic accountability?

This conference will delve into these critical dimensions, aiming to foster dialogue, debate, and understanding of the complex interplay between electoral processes, party politics, and democratic ideals in India. Let us embark on this intellectual journey together, with curiosity, courage, and commitment.

The authors should adhere to the following for both abstract and full-length paper:

- Every paper must be accompanied by a cover page, which should include the Thematic Panel, Title of the paper, name(s) of the author(s) and their affiliations, Contacts, E-mail Id and Correspondence Address.
- Papers are invited in both languages: English and Hindi.
- The Abstract & Research Papers should be in a MS Word Document format, (English Font: Times New Roman, Font size 12 and Hindi Font: Unicode, Font size 14) with 1.5 line spacing, 2.5 inch margins, aligned and 7th APA style of referencing. In-text citation is recommended.
- Abstracts should be limited to 300-500 words followed by 3 to 4 keywords.
- The Word Limit for Full Research Paper is limited to 3000-5000 words, and must include the following: Title, Objectives of the study, Research Questions, Methodology, Findings, Conclusion/Implications/Recommendations, Limitations (if any), References.
- Contributors are expected to follow Academic Ethics with respect to acknowledgment of any original idea or source materials adapted/adopted from others.
- Submit your abstract and paper in MS-Word and PDF format to the email: biharpsa2025@gmail.com
